- Note:**
1. In case of non-availability of Medical Social Officer (MSO) at Tehsil Headquarter Hospital (THQ), the concerned Social Welfare Officer (SWO), Community Development Project (CDP) will be member of the Board
 2. In case of non-availability of concerned Medical Specialist at Tehsil Headquarter Hospital (THQ), the case may be referred to the concerned District Headquarter Hospital (DHQ) for assessment with the approval of the Board. However, Disability Certificate will be issued by the Tehsil Disability Assessment Board (TDAB).

TORs:

The Board shall:

- i. Examine the persons with disabilities to assess the nature of his functional differentiability, aptitude, nature and ability to work in accordance with the regulations of the Council.

- ii. Issue Disability Certificates on the basis of assessment of the Board through Secretary of the Board.
- iii. Refer complicated cases for Expert Opinion / advice to Provincial Assessment Committee (PAC) constituted under Section (28) of the Act.
- iv. Implement Rules, Regulations, SOPs and Guidelines of the Council.
- v. Adhere to Disability Assessment Guidelines, 2018, while assessing the Persons with Disabilities (PWDs).
- vi. Implement decisions of the Council in letter and spirit.
