2. To ensure job placement of Persons with Disabilities (PWDs), in Private Establishments under available vacancies.
3. To coordinate with factories / establishments and visit those establishments for the employment of Persons with Disabilities (PWDs).
4. To maintain record of available vacancies in lieu of 3% quota for Persons with Disabilities (PWDs).
5. To establish and maintain data base of Persons with Disabilities (PWDs) employment, made so far in Private sector either on regular or adhoc basis etc.
6. To deposit funds in lieu of Non-Employment of Persons with Disabilities (PWDs) in Private Establishments.
7. To coordinate with Chamber of Commerce & Industries / Traders Groups for Implementation of 3% Disabled Quota in Private Sector.


